This study is about the state of education in closed regimes observed from the complexity theory.

There is an Adult Education Centre Nb 714 which depends on the General Directorate for Culture and Education of the Province of Buenos Aires. It will also study the social reintegration possibilities upon release at these centres based on the attitudes of the actors and taking into account the current international laws and recommendations. COLLABORATION FORUM

In accordance with the research done by Anton Van Kalmthout of the University of Tilburg (the Netherlands) about the application modalities of the pretrial detention measures and the bases for the Common European Regulations, emphasis is put on the fact that, in a lot of countries the pretrial detention of minors is done in worse conditions than that of adults. There is a need to develop minimum standards to protect the rights and the welfare of minors in pretrial detention, both concerning the maximum duration as the educational programmes, etc.
