In this interview, the Director of Psychology department and the Law-Psychiatry Program at the

Dr. Grisso underlines, that there is very little research evidence that screening and assessment lead to successful and effective treatment. He also presents his new area of study aiming at finding ways to improve mental health screening in juvenile justice for young people with diverse cultural backgrounds. [+]
