According to this year's UNODC World Drug report, the new Psychoactive Substances are largely a youth phenomenon in most countries. A European survey about youth attitudes, published in the UNODC report estimated that 5 per cent of the total of 12,000 young people interviewed, aged 15-24, had used at least one new psychoactive substance at some point in their lives.
